- 1 I am the sister of Ida L Woods, deceased, as well as the sister of Beatrice H White
- 2 I have concerns, based in part on recent past conduct, with respect to the future administrator of the estate
- 3 To date, there has been no accounting, ^{Roberta Strawbridge Moore} formal or informal, or inventory of insurance policies and proceeds and it appears that Strawbridge ^{Memorial Chapel} continues to be involved in the administration of the estate through its possession and control of insurance policies, without discussion of these facts with named policy beneficiaries
- 4 I have concerns that charges of the funeral home may be in excess of what was agreed to, as initially the funeral home was going to charge one amount and then said that amount would be reduced, but no information has been provided concerning the reduction No disclosures have been made to family members with respect to ongoing matters with the funeral home and the funeral home seems to be in control of insurance policies and has not disclosed policy beneficiaries
- 5 Various bank accounts of Ida L Woods have been closed or depleted without explanation and various policies of insurance unaccounted for
- 6 I have concerns that my sister, Beatrice, will be unduly influenced by her children to the detriment of the rightful heirs These concerns in part relate to the disposition of my sister's, Ida L Woods, home and car, and other possessions
- 7 I have no desire to become the administrator of the estate, but believe that an independent third party administrator ~~should be~~ appointed to protect heirs at law, including two of my brothers who are unable to care for themselves An independent administrator will help alleviate and avoid unnecessary family conflicts

- 8 While I understand that the Court, as a matter of procedure and law, is to be provided an accounting of all assets and what happens to them, I am concerned that full disclosure will not be made and neither the Court nor the heirs will know or be able to determine what has not been disclosed
- 9 I would ask that ^{Roberta STRAWBRIDGE Moore} Strawbridge Funeral Home provide a full disclosure of insurance policies or possessions including the name of the insurance company, the amount of the policy, and the listed beneficiary and disclose as well what has happened to the policies/proceeds
- 10 I realize that my sister's estate is not a large estate, but also know that my deceased sister would have wanted everyone to be treated fairly
- 11 I am not saying that my sister, Beatrice, has done anything dishonest, but do have concerns about the complete lack of information being provided and worry about matters in the future of the administration of the estate




